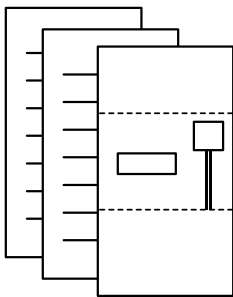

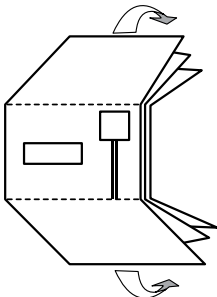

HOW TO USE THE BUSINESS REPLY ENVELOPE (BRE)

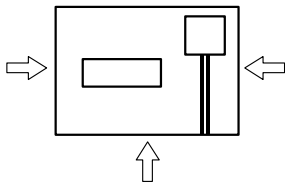
NOTE: Kindly fold along the dotted lines with this side facing out.



1. Place documents together with the BRE.

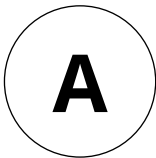


2. Fold inwards along the dotted lines as indicated.
