

## TERMS AND CONDITIONS GOVERNING CIMB RENOVATION-I FINANCING 0% PROCESSING FEE PROMOTION ("Promotion")

1. The Promotion is valid from 1 October 2021 to 28 February 2022, both dates inclusive (the "Promotion Period").

## **Eligibility Criteria**

- 2. To qualify for this Promotion, applicant must:-
  - a) Apply for a new CIMB Renovation-i Financing ("Eligible Product") issued by CIMB Bank Berhad, Singapore Branch ("CIMB Bank", "CIMB" or the "Bank") as main account holder within the Promotion Period ("Eligible Customer"). Joint applicant must be an immediate family member (parent, spouse or sibling);
  - b) Be a Singaporean and/or Singapore Permanent Resident aged 21 to 55 years old;
  - c) Earn a minimum annual income of \$\$24,000 for single or each joint applicant;
  - d) Apply for a minimum financing amount of \$\$10,000;
  - e) The Eligible Customer's application must be submitted to the Bank by 28 February 2022 and the Eligible Product must be accepted by the Eligible Customer and disbursed by the Bank by 31 March 2022.
- 3. Subject to these terms, if the Eligible Customer satisfies all the eligibility criteria set out in Clause 2 ("Qualified Eligible Customer"), the Qualified Eligible Customer will be eligible for 0% processing fee via cash rebate ("Gift") upon disbursement. The Gift will be credited into the Qualified Eligible Customer's dedicated Current/Savings account used to pay the monthly instalment for the Eligible Product 2 months after the disbursement.
- 4. For the avoidance of doubt, the Qualified Eligible Customer will only receive the discounted 0% processing fee on the Eligible product based on the main account holder if there are multiple Eligible Products applied for

- 5. The new Eligible Product account must be in good standing and conducted in a proper and satisfactory manner as determined by the Bank in its sole discretion to be eligible for the Promotion. In the event that the relevant Eligible Product account is cancelled, voluntarily or involuntarily closed, terminated or suspended for any reason whatsoever, the Bank may determine at its absolute discretion to forfeit the Gift and the Qualified Eligible Customer shall not be entitled to any compensation or payment whatsoever.
- 6. CIMB Bank reserves the right to replace the Gift (with an item of similar value) at its sole and absolute discretion at any time without prior notice.
- 7. CIMB Bank accepts no liability for any late approval of any Eligible Product application due to insufficient, incomplete or illegible applications or any other reasons whatsoever.
