

Terms and Conditions Governing the CIMB PrivateCAR Motor Insurance Promotion 2020

Eligibility

- 1. The Promotion is organised by CIMB Bank Berhad, Singapore Branch ("CIMB Bank" or the "Bank") and supported by Sompo Insurance Singapore Pte. Ltd. ("Sompo").
- 2. The Promotion period is from 15 January 2020 to 30 December 2020 (the "Promotion Period").
- 3. The Promotion is applicable to participants who submit an application via a CIMB Bank Dedicated Channel as defined in clause 5 below, successfully purchase a Sompo PrivateCAR policy ("PrivateCAR") and have PrivateCAR issued during the Promotion Period.
- 4. Each participant who purchases PrivateCAR in accordance with clause 3 above shall be entitled to 20% discount off the premium for PrivateCAR.
- 5. A "CIMB Bank Dedicated Channel" means:
 - a. Online application on CIMB Bank website via https://www.cimbbank.com.sg/privatecar; or
 - b. Physical application form submitted or mailed in to either of the following CIMB Bank branches. The application form is only deemed submitted upon CIMB Bank's actual receipt of the same.

 - c. Physical application form mailed in to Sompo at 50 Raffles Place #05-01/06, Singapore Land Tower, Singapore 048623. The application form is deemed submitted upon Sompo's actual receipt of the same.
- 6. The Promotion is only applicable to new PrivateCAR purchased from CIMB Bank Dedicated Channel(s) and issued during the Promotion Period. The Promotion is not applicable to existing Sompo PrivateCAR policy holders.

General

- 1. Each of CIMB Bank and Sompo reserves the right in its sole and absolute discretion to determine whether a participant qualifies for the Promotion. If CIMB Bank and/or Sompo determines that a participant is not eligible, CIMB Bank and/or Sompo reserves the right not to allow the participant to participate in the Promotion.
- 2. By participating in the Promotion, all participants agree and consent that CIMB Bank and/or Sompo may collect, use, disclose and/or process their personal data (in the case of a corporate policy, personal data of individuals in relation to the policy) in accordance with the Personal Data Protection Act 2012 for the purposes and uses described in CIMB Bank's Terms and Conditions Governing Personal Data Protection Act (PDPA) 2012 (available on www.cimbbank.com.sg) and Sompo's Privacy Policy (including the provision of protection, services related to this insurance policy, screening activities in accordance with legal/regulatory obligations/risk management procedures) (available on www.sompo.com.sg). For the purposes stated below, all participants confirm that they have read and agree to be bound by the terms stated therein, as may be amended, supplemented and/or substituted by CIMB Bank from time to time:
 - a. disclosing the personal data of the participants to Sompo in connection with the Promotion;
 - b. administering and conducting the Promotion;
 - processing of the application for PrivateCAR and administrating PrivateCAR; and/or
 - d. providing marketing material and information sent by Sompo on their products and services via ordinary post, electronic mail, text message and/or phone call.



- 3. Each of CIMB Bank and Sompo reserves the right to terminate or suspend the Promotion or amend, revoke, vary, delete or add to any of these terms and conditions at their absolute discretion at any time without any liability and such changes shall be binding on participants with effect from the earliest of the following:
 - a. the date CIMB Bank places notice of such changes on its Singapore website;
 - b. the day after CIMB Bank sends notice of such changes to the participant's last known address in the records of CIMB Bank by ordinary post;
 - c. the date after CIMB Bank sends notice of such change to the participant by short messaging system (SMS) or electronic mail; and/or
 - d. the date CIMB Bank places such notice at all of its branch(es) in Singapore.
- 4. Any termination, suspension, amendment or variation of the Promotion or the terms and conditions herein by CIMB Bank or Sompo shall not entitle any participant to any claims or compensation from CIMB Bank or Sompo for any and all losses or damages suffered or incurred by that participant, whether directly or indirectly caused.
- 5. Each of CIMB Bank and Sompo shall not be liable in any manner for any consequences, claims, losses, damages, injury, liabilities or expenses suffered or incurred arising out of or relating to, the Promotion, whether directly or indirectly caused, including but not limited to any hardware or software breakdown, malfunction or defects in any computer system or equipment and/or any incomplete, lost, late, damaged, illegible or misdirected notices, letters, application forms and/or correspondences.

- 10. In the event of any inconsistency between these terms and conditions and any other terms and conditions, application form, brochure, promotional or marketing material relating to the Promotion, these terms and conditions shall prevail to the extent of matters relating to the Promotion.
- 11. These terms and conditions shall be governed by the laws of Singapore and the participants in the Promotion irrevocably submit to the non-exclusive jurisdiction of the courts of Singapore.
- 12. A person who is not a party to any agreement governed by these terms and conditions shall not have any right under the Contracts (Rights of Third Parties) Act (Cap. 53B) to enforce any of these terms and conditions.

- 14. PrivateCAR is underwritten by Sompo and distributed by CIMB Bank.
