

TERMS AND CONDITIONS GOVERNING THE CIMB PERSONAL LOAN ROADSHOW PROMOTION DECEMBER 2023

- 1. The CIMB Personal Loan Roadshow Promotion December 2023 ("Promotion") is held from 15 December 2023 to 31 March 2024, both dates inclusive ("Promotion Period").
- 2. To be eligible for this Promotion ("Eligible Customer"), applicant must:
 - a. apply for a CIMB Personal Loan ("Facility") at our CIMB roadshows at various locations within the Promotion Period; and
 - b. submit the application for the Facility within the Promotion Period and the application must be approved by CIMB Bank Berhad, Singapore Branch ("CIMB" or "CIMB Bank") in its absolute discretion by 15 April 2024.
