

**Terms and Conditions Governing CIMB PayEasy S\$10 Shopee Vouchers Promotion 2026**

1. The CIMB PayEasy S\$10 Shopee Vouchers Promotion 2026 (“Promotion”) is held from 07 May 2026 to 31 May 2026 both dates inclusive (the “Promotion Period”).

**Eligibility Criteria**

2. To qualify for this Promotion: -
  - a) Applicant must apply for the CIMB PayEasy Credit Card (“Eligible Card”) issued by CIMB Bank Berhad, Singapore Branch (“CIMB Bank”, “CIMB” or the “Bank”) via the SimplyGo Mobile Application within the Promotion Period and;
  - b) Make a top up transaction of at least S\$100 to their EZ-Link wallet within the SimplyGo Mobile Application within 30 days of Eligible Card approval date.
3. Subject to these terms, if the participant satisfies the eligibility criteria set out in Clause 2, the participant will receive the Gift, subject to fulfilment of the corresponding Qualifying Spend within the specified Qualifying Period as set out below (“Qualified Participant”):

4. For the avoidance of doubt, the Qualified Participant will only receive a maximum of one (1) Gift where applicable.
5. The Gift will be sent in the form of a redemption code to the Qualified Participant’s registered email address with the Bank within 8 weeks after the Promotion Period.

**General Terms and Conditions**

6. In order to be eligible for the Promotion, the application for the Eligible Card must be successfully approved no later than 07 June 2026.
7. The Eligible Card account must be in good standing and conducted in a proper and satisfactory manner as determined by the Bank in its sole discretion to be eligible for the Gift. In the event that the relevant card account is cancelled, voluntarily or involuntarily closed, terminated or suspended for any reason whatsoever, the Bank may determine at its absolute discretion to forfeit the Gift and the participant shall not be entitled to any compensation or payment whatsoever.

8. CIMB Bank reserves the right to replace the Gift (with an item of similar value) at its sole and absolute discretion at any time without prior notice.
9. CIMB Bank accepts no liability for any late approval of any credit card application due to insufficient, incomplete or illegible applications or any other reasons whatsoever.
10. CIMB Bank assumes no responsibility for incomplete, incorrect, lost, late, damaged, illegible, misdirected forms and/or other forms of communication which may result in the ineligibility of the participant to participate in this Promotion or to receive any Gift.
11. This Promotion is not valid in conjunction with other promotional offers unless otherwise stated.
